

## SERRE CHEVALIER JUNIOR TOURNAMENT

### TRIP DETAILS

#### Date

26 to 30 October 2009, Half-term

#### Location

Briançon in Serre Chevalier Valley, France

#### Price

From £425 per child, plus flight. The price includes full board accommodation, two coaches travelling with the group, tennis coaching in preparation for the tournament, return airport transfers and tournament entry fee.

From £375 per non-playing child/adult wishing to join the trip, plus flight. The price includes full board accommodation and return airport transfers.

#### Travel

The group will be traveling from Gatwick to Lyon with Easyjet. **Parents are responsible for booking the flight(s) [www.easyjet.com](http://www.easyjet.com)**, (this keeps the costs down). Flight details are shown below. Please note that the earlier the flight is booked the cheaper it will be. At present the flights are approximately £68 each. Once the flight is booked please send us a copy of the flight confirmation.

- Monday 26 October departing Gatwick on flight **EY5003 at 07:15 arriving in Lyon at 09:55**
- Friday 30 October departing Lyon on flight **EY5006 at 21:25, arriving in Gatwick at 21:55**

#### Getting to Gatwick Airport

Please ensure that everyone is at the airport by 05:15 on Monday 26 October.

#### Transfer to Briançon and back to Lyon airport

On arrival in Lyon, the group will be met by two minibuses and taken to the hotel in Briançon. For the return journey, the group will be taken back to Lyon airport. The transfer time is approximately 2 ½ hours.

#### Travel Insurance

It is a booking requirement that everyone has suitable travel insurance and any medical conditions/regular medication is declared to their insurer. Please make sure that all players have cover for **playing in tournaments**. Please check with your insurance company if your policy covers this, if not you **must** ensure suitable cover is arranged prior to departure and provide us with a copy of the insurance certificate.

Please ensure that each person travelling has an **EHIC card** (former E111), this provides some medical provision to UK nationals under reciprocal health agreement between EU Countries.

## Accommodation

The group will be staying at CIPPA sports complex, (Centre International de Preparation Physique en Altitude - *The international centre for physical preparation at high altitude*), with full board accommodation. <http://cippa.com/index-gb.htm>

The centre is just a couple of minutes walk from the Briançon Tennis Club (where the tournament will take place) and from the PARC Briancon 1326 Swimming and ice skating complex

## BRIANÇON IN SERRE CHEVALIER VALLEY, FRANCE

### **BOOKING:**
